Covering the testing and documentation of Yield, Vegetable Matter Base, Fibre Diameter, as well as the control and supervision of sampling and weighing of each bale in the lot for Wool and Mohair for Normal Service Time. Sampling at WTB Port Elizabeth sites.

- Lot sizes over 20 bales: Fee for 20 bales plus R2.60 per bale for each additional bale.
- The fee for all Interlots (Grouping Lots): R296.80 per lot.
- Lots with a total greasy weight exceeding 12000 kg must be split into sub lots of approximately equal size not exceeding 12000 kg each. Sub lots are sampled, tested and charged separately, but a single combined result for the total lot is issued.
